1. The meeting was called to order at 1:12 p.m. by Board Member Morgan Patterson.
2. Welcome of guests
There were no guests.
3. The minutes of the February 18, 2021 meeting were presented for approval; there were no changes.

4. Board Member Morgan Patterson discussed that Police Detective Johanna Iribe was no longer employed by YPD as of 03/05/21. Johanna Iribe did not pull out her retirement and plans to come back within 2 years.
5. Board Member Morgan Patterson presented the election to terminate participation in the Deferred Retirement Option Plan (DROP) and apply for normal retirement by Brian Scanlan for approval. Board Member Morgan Patterson reviewed the application and notification and determined they were properly completed – Effective 4/29/2021; Years of Service: 25.460 Monthly Pension: \$5,161.85.

6. Board Member Morgan Patterson stated that Juan J. Cazares had been re-hired as a civilian employee (Evidence Technician) for the City of Yuma Police Department. The position Juan J. Cazares applied for opened after he retired and it was a competitive process. An ACR is not required and he is not in a supervisory position. Juan J. Cazares retired as a sworn police officer on 8/20/2007 and he was hired more than 60-90 days after he retired. He was re-hired with the City of Yuma on February 8, 2021. A job description of both his previous job as a police officer and his new job as an evidence technician will be mailed to PSPRS.
