ORDINANCE NO. O2022-011

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF YUMA, ARIZONA, AMENDING THE YUMA CITY CODE, TITLE 15, CHAPTER 150, SECTIONS 150-076, 150-077, ADOPTING BY REFERENCE THE NFPA 70 NATIONAL ELECTRICAL CODE 2020 EDITION, AND THE AMENDMENTS RECOMMENDED BY THE BUILDING ADVISORY BOARD DATED FEBRUARY 2, 2022, AND PROVIDING A PENALTY FOR VIOLATIONS THEREOF

WHEREAS, on July 15, 2015, the City Council adopted the NFPA 70 National Electrical Code 2014 Edition and the 2006 International Code Council Electrical Code Administrative Provisions; and,

WHEREAS, Yuma City Council Resolution No. R2022-021 declared a document titled, "NFPA 70 National Electrical Code 2020 Edition" a public record; and,

WHEREAS, the City Council has considered the recommendation of the Building Advisory Board based on their actions taken at the meeting of February 2, 2022 recommending adoption of the NFPA 70 National Electrical Code 2020 Edition, and the amendments within this Ordinance; and,

WHEREAS, up to date modern codes help protect the built environment from natural disasters and fires, and offer safe environments for the occupants for both residential and commercial structures; and,

WHEREAS, the City of Yuma is desirous to adopt the NFPA 70 National Electrical Code 2020 Edition and the amendments herein, to keep current with the code cycle and amendments to reflect modern technology, materials and techniques.

NOW THEREFORE, BE IT ORDAINED by the City Council of the City of Yuma as follows:

<u>SECTION 1</u>: The Yuma City Code Title 15, Chapter 150, Section 76 is amended to delete the following strikethrough text and insert the following underlined text:

§ 150-076 Adoption of NFPA 70 National Electrical Code 2014 2020 Edition and 2006 International Code Council Electrical Code Administrative Provisions.

Certain documents, three copies of which are on file as public record in the office of the City Clerk of the City of Yuma, marked and titled, "known as the NFPA-70 National Electrical Code 2014 Edition NFPA 70 National Electrical Code 2020 Edition and 2006 International Code Council Electrical Code Administrative Provisions 2006 International Code Council Electrical Code Administrative Provisions, and Amendments dated March 11, 2015 were declared a which was made public record by Resolution R2015 028 R2022-021, with certain amendments listed herein, and are is hereby adopted by reference and made a part hereof as if fully set out herein in this article.

<u>SECTION 2</u>: The Yuma City Code Title 15, Chapter 150, Section 77 is amended to delete the following strikethrough text and insert the following underlined text:

§ 150-077 Amendments.

The following amendments, additions, and deletions are hereby made to the NFPA—70 National Electrical Code 2014 Edition NFPA 70 National Electrical Code 2020 Edition and 2006 International Code Council Electrical Code Administrative Provisions 2006 International Code Council Electrical Code Administrative Provisions, as adopted by this subchapter. Paragraphs and section numbers refer to the National Electrical Code (NEC) and International Code Council Electrical Code Administrative Provisions numbering systems. Code references not appearing amended in this section, as amended, shall be enforced as published in the reference document.

- (A) The requirements of the most current Arizona Public Service (APS) Electrical Service Manual shall supersede the requirements of the NEC when the APS requirements are more restrictive.
- (B) Where reference is made to the Fire Code it shall mean the current adopted Fire Code.
- (C) Article 210.8 Ground-Fault Circuit-Interrupter for Personnel. (F) Outdoor Outlets. Add 2 additional exceptions to section, as follows:
- 2. Air conditioning equipment where an approved grounding lug and an additional properly grounding conductor is attached to the equipment chassis.
- 3. Air conditioning equipment located on roofs or within locked and maintained equipment enclosures that are not accessible to the public.
- (<u>CD</u>) Article <u>310.106(A)</u> <u>311.12(A)</u> Minimum Size of Conductors. Amend to read, "The minimum size of conductors shall be as shown in Table <u>310.106(A)</u> <u>311.12(A)</u>. Whether solid or stranded, conductors, other than signal or control wiring, shall not be smaller than #12 Copper or #1 Aluminum or Copper-Clad Aluminum for current carrying conductors."
- (\underline{DE}) Amend Table $\underline{310.106(A)}$ $\underline{311.12(A)}$ as follows:

- (EF) Article 334.10 Uses Permitted. Amend to read, "Type NM, and Type NMC, and Type NMS cables shall be permitted to be used in residential Group R-3 and their related U structures. Type NM, and Type NMC, and Type NMS cables shall be permitted to be used in Residential Group R-1, Residential Group R-2, Institutional Group I-1, and Residential Group R-4 and their related U structures, for branch circuits only. The branch circuits shall serve only one residential unit and shall originate in a panel or junction box located on or within the unit served."
- (FG) Article 394.10 Uses Permitted. Amend to read, "Use of Concealed knob-and tube wiring shall be limited to the maintenance and repair of existing installation. No knob-and-tube wiring shall be extended or otherwise altered to provide additional points of utilization or used to establish new circuits."
- (GH) Article 338.10 Uses Permitted (A) Service Entrance conductors. Amend to read, "Type SE and USE cable shall not be used as service-entrance conductors."
- (H) Article 690.56 Identification of Power Sources. Subpart (C) Facilities with Rapid Shutdown. Add to end of section. "The required plaque or directory shall be located on or adjacent to the utility service entrance section."
- (I) Chapter 1. ICCEC Administrative Provisions. Section 101.1 Title. Amend to read, "These regulations shall be known as the *Electrical Code-Administrative Provisions* of City of Yuma, Department of Community Development, Building Safety Division and shall be cited as such and will be referred to herein as 'this code."
- (J) Section 102.6 Referenced codes and standards. Amend first sentence to read, "The codes and standards referenced in this code shall be those that are listed in Chapter 13 and such codes and standards shall be considered part of the requirements of this code to the prescribed extent of each such reference, except that where duplications of reference standards are included in the building and fire codes, the reference standard numbers of the current adopted building and fire codes shall govern."
- (K) Chapter 3. Section 301.1 Creation of enforcement agency. Delete all reference to Department of Electrical Inspection, and amend first sentence to read, "The Department of Community Development, Building Safety Division is hereby created and the official in charge thereof shall be known as the eode <u>building</u> official."
- (L) Chapter 4. Section 404.2 Schedule of permit fees. Insert Electrical Permit Fee Schedule Table 1-A, as follows:

5. Power Apparatus

For motors, generators, transformers, rectifiers, synchronous converters, capacitors, industrial heating, air conditioners and heat pumps, cooking or baking equipment and other apparatus, as follows:

Rating in horsepower (HP), kilowatts (kW), kilovolt-amperes (kVA) or kilovolt-amperes-reactive (kVAR):

Up to and including 1, each	5.00
Over 1 and not over 10, each	13.00
Over 10 and not over 50, each	25.00
Over 50 and not over 100, each	50.00
Over 100, each	67.00

Notes:

- 1. For equipment or appliances having more than one motor, transformer, heater, etc., the sum of the combined ratings may be used.
- 2. These fees include all switches, circuit breakers, contactors, thermostats, relays and other directly related control equipment.

6. Busways

Note: An additional fee is required for lighting fixtures, motors and other appliances that are connected to trolley and plug-in-type busways. A fee is not required for portable tools.

7. Signs, Outline Lighting and Marquees

8. Services

9. Miscellaneous Apparatus, Conduits and Conductors

Note: This fee is not applicable when a fee is paid for one or more services, outlets, fixtures, appliances, power apparatus, signs or other equipment.

- * Or the total hourly cost to the jurisdiction, whichever is greater. This cost shall include, supervision, overhead, equipment, hourly wages and fringe benefits of the employees involved.
- (M) Section 404.3 Work commencing before permit issuance. Amend to read, "Any person who commences work before obtaining the necessary permits shall be subject to the usual fee and an additional investigation fee. An investigation fee, in addition to the permit fee, shall be collected whether or not a permit is then or subsequently issued. The investigation fee shall be determined by the <u>eode building</u> official, based on the circumstances, nature and severity of the infraction. The minimum investigation fee shall be \$50 and the maximum shall be an amount up to the same as the fee set forth in Table 1-A."
- (N) Amend section Section 404.5 Refunds. Amend and add to end of section, "The eode building official shall authorize the refunding of fees as follows:
- 1. The full amount of any fee paid hereunder which was erroneously paid or collected.
- 2. Not more than 80 percent of the permit fee paid when no work has been done under a permit issued in accordance with this code.
- 3. Not more than 80 percent of the plan review fee paid when an application for a permit for which a plan review fee has been paid is withdrawn or canceled before any plan review effort has been expended.

The building official shall not authorize the refunding of any fee paid except upon written application filed by the original permittee not later than 180 days after the date of fee payment."

- (O) Section 1003.1 Penalties. Amend sentence to read, "Any person who fails to comply with the provisions of this code or who fails to carry out an order made pursuant of this code or violates any condition attached to a permit, approval or certificate shall be subject to the penalty and fine described in Section 5 of this ordinance." Penalty, see §150 999
- (P) Section 1004.3 Unlawful continuance. Amend sentence to read, "Any person who shall continue any work in or about the structure after having been served with a stop work order, except such work as that person is directed to perform to remove a violation or unsafe condition, shall be subject to the penalty and fine described in Section-5-of this ordinance".
- (Q) Chapter 11. ICCEC Administrative Provisions. Section 1102.1 Membership of board. Amend to read, "The membership of the Building Advisory Board, as prescribed in Section 150-008 of the Yuma City Code, will be the Board of Appeals."

- (R) Delete Sections 1102.2 through 1102.4 1102.7 in their entirety.
- (S) Section 1103.5 Postponed hearing. Amend to read, "When 9 members are not present to hear an appeal, either the appellant or the appellant's representative shall have the right to request a postponement of the hearing."
- (S) Delete Sections 1103.1 through 1103.7 in their entirety.
- (T) Chapter 12. Delete Section 1202.2 Nonmetallic-sheathed cable
- (U) Chapter 13. Under heading "NFPA" revise standard reference number from "70-08" "70-14" to "70-14" "70-20."

SECTION 3: All ordinances or parts of ordinances in conflict with the provisions of this Ordinance are hereby repealed, effective thirty (30) days from the adoption hereof. All ordinances or parts of ordinances not amended or repealed by the provisions of this Ordinance shall remain in full force and effect.

<u>SECTION 4</u>: This Ordinance does not affect the rights and duties that matured, penalties that were incurred, or proceedings that were begun before the effective date of this Ordinance.

<u>SECTION 5</u>: If any section, subsection, sentence, clause, phrase or portion of this Ordinance is for any reason held to be invalid or unconstitutional by the decision of a court of competent jurisdiction, such decision shall not affect the validity of the remaining portions thereof.

<u>SECTION 6</u>: Violations of this Ordinance are subject to the following penalties:

It shall be unlawful for any person, firm or corporation to violate, or cause the violation of, any provision of the ordinance. Any person, firm or corporation violating any of the provisions of this ordinance shall be deemed guilty of a class 1 misdemeanor and shall be punished by a fine not to exceed \$1,000, or by imprisonment for not more than ten days, or by both fine and imprisonment. Each separate day or part thereof during which any violation of this ordinance occurs or continues shall be deemed to constitute a separate offense, and upon conviction thereof, shall be punishable as herein provided.
