<u>Drought Preparedness and Management Plan Presentation</u>

Jeremy McCall used a power point to go over Drought Preparedness and Management plan. A hard copy of the power point was handed out to the Commission could follow along. Each member also received a copy of the 2022 City of Yuma Drought Preparedness and Response Plan that will be presented to Council this Wednesday evening. The plan will also be available on our website.

- Colorado River-basin is 250,000 square miles with 7 states divided in
 There are 4 upper level states and 3 lower lever and 2 Countries;
 America and Mexico.
- Bureau of Reclamation held a Senate meeting on June 16th and went over some of the projections. On June 14th they released their mid-term projections for the Colorado River. Every year around this time they release those documents and they go into a Water Year Forecast.
 - Mid-Term Projections- If water inflow is below average we are vulnerable to falling below the 3,525'/1,020' combined lake volumes if we don't act. Even with a good year, we can quickly be back in the same position we are in today, or worse. If 2023 inflow is like 2022 an additional 2.5 maf to stay above the 3,525'/1,020 combined storage volumes.
 - Each year we fall short of protecting whatever elevations we choose to protect, the volumes needed to stabilize the system in future years.
