APPROVAL OF MINUTES

Motion by Commissioner James Sheldahl, second by Commissioner Chris Hamel to APPROVE the minutes of November 8, 2023. Motion carried unanimously, (6-0) with one absent.

ITEMS REQUIRING COMMISSION DISCUSSION AND ACTION

<u>DHRC-42063-2023:</u> This is a request by Mic Homes, Inc., on behalf of Theo Rush, to construct a new accessory dwelling unit, in the Century Heights Conservancy Residential Historic District, for the property located at 452 S. 1st Avenue, Yuma, AZ.

Amelia Domby, Senior Planner summarized the staff report and recommended APPROVAL.
