Provide a narrative of BMP effectiveness, including qualitative and quantitative indicators, in addressing pollutant discharge to this receiving water.

Our current BMP has been effective for reducing selenium discharge to the Colorado River at all four (4) of our mapped outfall locations. During this reporting period there was not exceedance of site-specific criterion (2.2 Mg/L) of selenium based on laboratory analysis of the reporting period rain events.

The City has been cleaning retention basins in the Priority Area annually for several years, but had not jet cleaned the pipes that convey stormwater to the river. In an effort to reduce selenium reaching the river, the City jet-cleaned the four Outfalls and simultaneous vacuum the first flush from this process upstream of the outfall in an effort to capture polluted material before it reaches the river. We took samples over the course of this process in order to gage its efficacy. We sampled clean water at the end of the process in order to create a baseline. This reporting period we did not have an exceedance of Selenium
