Approval of minutes:

a. Jaime McGalliard, seconded by Brannick Harris, made a motion to approve the May 16, 2024, meeting minutes as presented. The motion carried by the following votes: Aye: 4 Brannick Harris, Raul Canal, Judy Phillips, and Jaime McGalliard. Nay: None.

 - i. Review Final Draft Plan

 - Steve Duh with Concentrix presented the following:
 - Capital Investment Priorities:
 - Near term (1-3 years): continue to implement renovations and replacements of play playgrounds, parks restrooms, park ramadas; upgrade and install field lighting, fencing, and athletic field support infrastructure; implement citywide ADA Transition Plan to ensure universal accessibility; construct Phase I of the east Mesa Community Park; Upgrade and redevelop Kennedy Park Skate Park; implement irrigation system replacement and turf restoration at Desert Hill Golf Course and Desert Hills Par 3 Course.
 - Mid-term (4-5 years): install additional pickleball courts; add new or replace exercise stations at various parks; explore options to install additional splash pads; Master plan the future 10-acre Ocotillo Desert Park and 10-acre Cielo Verde Park; implement annual shade tree plantings at various parks.
 - Long-term (6-10 years): convert Kennedy and Shaw fields to artificial turf; construct subsequent phases of East Mesa community Park; identify and install up to two more dog parks citywide; identify location for a second skate park and a second inline skate rink.
 - Non-Capital or Policy Projects:
 - Parks & operations near term (1-3 years): continue to utilize Lucity asset management system to track down work orders, repairs, and labor; develop a master plan for a shade tree program for planning annual tree plantings; support the implementation of Bikeways Plan.
 - Parks & operations Mid-term (4-5 years): establish design standards for park furnishings.

- Parks & operations Long term (6-10 years): Maintain and continue to update a revolving list of potential small works or volunteerappropriate projects.
- Non-Capital or Policy Projects:
 - Recreation programming near term (1-3 years): establish an overall programming philosophy to guide program decisions; complete an Indoor Recreation Center and an Aquatic Facility feasibility study; update intragovernmental agreement with school districts and establish formal agreement s with co-sponsors.
 - Recreation Programming Mid-term (4-5 years): establish comprehensive athletic fields use policy and field capacity analysis; prepare a marketing plan to support recreation, arts, events and facilities; continue to foster agreements or partnerships with programming partners.
 - Recreation programming Long term (6-10 years): develop periodic,
 5-year recreation program plans to guide the direction of City programming to include a framework for City staff produced, contracted, and partner program areas.
- Non-Capital or Policy Projects:
 - Arts & Culture near term (1-3 years): pursue collaborations and partnerships to expand the audiences for outdoor events; coordinate with Visit Yuma to ensure their app is up-to-date and cross-promote the app to broaden public awareness; continue to coordinate with local artist, galleries, and art organizations to periodically refresh the major events and explore other options to engage the community with the arts.
 - Arts & Culture Mid-term (4-5 years): conduct a cultural arts facility space study to identify the space and configuration needs for current and future offerings; enhance or develop an updated, user- and mobile - friendly website that showcases the City's arts and cultural facilities, program, events, and ticket information.
 - Arts & Culture Long term (6-10 years): continue to coordinate with local artist, galleries, and art organizations to periodically refresh the major events and explore other options to engage the community with the arts.
